SECTION 1 INTRODUCTION

1.1 A Universal Income Opportunity – P1D and netTrav.com

Platinum One Destinations (P1D) has developed a state of the art Compensation Plan that is designed to reward those who are willing to apply diligent effort in the selling of P1D and netTrav.com travel products. Representatives earn through their own efforts with direct sales or as a team builder growing a sales organization by recruiting, training, leading and motivating others to do the same.

The P1D compensation plan has EIGHT INCOME STREAMS built around these FOUR concepts:

1. Direct Sales
2. Residual Team Earning Center
3. Affinity Lines (Qualification Sales)
4. Leadership Bonuses

There are two commission programs within the P1D Compensation Plan structure.

1.2 netTrav.com Direct Commission Program: 2 Income Streams

As a netTrav.com Affiliate, representatives can earn 2 income streams:

1. Earn commission on travel booked through your netTrav.com Website.
2. Earn Direct Commission on all netTrav.com memberships that are purchased from you.

1.3 Platinum One Destinations Accelerated Wealth Program: 8 Income streams

The Accelerated Wealth Program has 8 Income Streams: 4 Up Front Direct Income Streams and 4 Powerful Residual Income Streams. These will be described in detail later in this document.

SECTION 2 WHAT IS A CONSUMER, CONSUMER MEMBER AND INDEPENDENT REPRESENTATIVE

Platinum One Destinations and netTrav.com are in the business of acquiring new consumer customers who purchase our retail products. Our retail products include travel that is booked on any Member's netTrav.com Travel Website, netTrav.com Memberships sales and P1D Silver, Gold and Platinum Membership sales. All netTrav.com Memberships and P1D Memberships include your own personal netTrav.com Travel Website.

2.1 Consumer:

Anyone who books travel from a Consumer Member or an Independent Representative's netTrav.com site.

2.2 Retail Member:

Anyone who has purchased their own netTrav.com membership or a Silver, Gold or Platinum Membership.

2.3 Independent Representative (Representative):

A person, persons or legal business entity that has joined netTrav.com or P1D with the intent to generate income by participation in the P1D Accelerated Wealth Program and/or the netTrav.com Direct Commission program.

2.4 Sponsor:

A sponsor is the Representative (1) from whom you purchased your Retail Membership or (2) who brought you into netTrav.com or P1D as a Representative.

2.5 Upline:

Your Upline may consist of numerous P1D Representatives. For example: Your Sponsor's Sponsor is part of your Upline. Their Sponsor is also known as your Upline. You will have support from Executive Marketing Associates and Executive Leaders in Your Upline. At any time, you may request information on your Upline Sponsorship from P1D live member support.

2.6 \$49 Activation Fee/Online Business System

A \$49 Activation Fee is required to become an Affiliate, netTrav.com Affiliate or a P1D Marketing Associate. This is a non-commissionable fee and covers the cost of your Online Business System which includes, but is not limited to, the following business products and services:

1. <http://www.platinumonedestinations.com/memberID> - Independent Business Reps who choose not to use the optional P1D MAC Solution, developed and maintained by SMG, our exclusive sales and marketing organization, can utilize this site to directly process customer orders.
2. P1D Back Office with automated tracking of Affiliates, Team and Affinity Lines.
3. Automated Commission Tracking and Reporting System.
4. Corporate Communiqués and Updates from P1D.
5. Live Member Support, available Monday through Friday.

The Online Business System renewal Activation Fee is \$25 per year, beginning on your starting date one year anniversary.

2.7 Affiliate and netTrav.com Affiliate

2.7.1 Affiliate (A):

An Affiliate is a representative of P1D or netTrav.com who has purchased a \$49 Business Kit with the intent of generating income representing P1D/netTrav.com Travel Products, Services and Memberships.

2.7.2 netTrav.com Affiliate (AN):

Is a representative who has purchased the \$49 Online Business System and their own personal netTrav.com membership.

2.8 P1D Accelerated Wealth Program

2.8.1 ACCELERATED WEALTH COMMISSION LEVELS

2.8.1.A P1D Marketing Associate (MA)

Is a representative who has purchased the \$49 Online Business System and a Silver, Gold or Platinum P1D Membership. A P1D Membership includes your own personal netTrav.com Membership. You are qualified to receive RTEC and netTrav.com membership commissions until qualified at EMA.

2.8.1.B P1D Executive Marketing Associate (EMA)

Is a representative who has qualified for all Commissions at a Silver, Gold or Platinum Level.

2.8.1.C P1D Executive Leader (EL)

Is a representative that was an EMA who has qualified for Leadership Bonuses at the Gold and/or Platinum Level.

2.8.2 8 ACCELERATED WEALTH COMMISSION TYPES

(These will be described in detail later in this document)

2.8.2.A 4 Up Front Income Streams

1. **netTrav.com Membership Commission** - Commission paid to you on all personally sold netTrav.com Memberships. netTrav.com Memberships are renewable annually and you are also paid on the annual renewal fee.
2. **P1D Membership Sales (EMA)** - Commission paid to you on your personal sales of Silver, Gold or Platinum Memberships. P1D Memberships are renewable annually and you are also paid on the annual renewal fee.

3. **P1D Qualifying Affinity Line Commission (EMA)** - Commission paid to you from the qualifying sales made by your downline Team Members sales of Silver, Gold or Platinum Memberships.
4. **Travel Rebates and Commissions** – You receive discount rebates on your own travel and commissions on travel booked through your Membership .

2.8.2.B 4 Residual Income Streams

1. **RTEC Direct** - Commission paid to you from P1D Member placements in your RTEC.
2. **RTEC 50% Matching Bonus (EMA)** - When a Member who you personally sponsor is paid RTEC Direct Commission, you receive a 50% match of their commission.
3. **P1D Upgrades and P1D Overrides (EMA)**
 - **Upgrade Commissions** paid to your from Membership Upgrade purchases made by downline Members.
 - **Override Commissions** paid to you from sales made by your downline where the Membership sale is at a higher Membership Level than the downline Member owns.
4. **Executive Leader Bonus (EL)** – Bonus Commissions paid to first Upline Executive Leader(s) on all Gold and Platinum Membership sales.

SECTION 3 P1D ACCELERATED WEALTH GENEALOGY AND ORGANIZATIONAL STRUCTURE

Platinum One Destinations’ success is driven by our Independent Representatives’ successes. P1D has designed a proprietary compensation plan to richly reward those who successfully (1) sell netTrav.com Travel Products, netTrav.com memberships and P1D Memberships and successfully (2) build a sales organization by recruiting, training and motivating others to do the same.

Independent Representatives who build sales organizations benefit from 8 Powerful Income Streams on the sales revenue their organization generates. Our Genealogy software automatically tracks and records all sales that are made in your organization, and the independent reps who now join your organization as a result of those sales. We track all sales and relationships in two ways: (1) Your Team Organization and (2) Affinity Line Organization.

3.1 Team Organization (Your Direct Sales)

Your Team Organization consists of the Representatives who you personally sponsor as a qualified Executive Marketing Associate. ALL Representatives who you personally sponsor will be displayed in your back office in “Affiliate Members”. Your first 2 P1D Membership sales are qualifying sales that are passed up to your sponsor who receive the commissions from their purchases and they become are part of your sponsor’s “Affinity Line” Organization and are listed in your sponsor’s “Affinity Line” report as a training sale from you. They are also listed in your “Affinity Line” report as training sales from you to your sponsor. These first 2 P1D

Membership sales qualify you to become an Executive Marketing Associate. All of your personal P1D Membership sales beginning with your 3rd sale make up your Team Lines and you will receive Direct Commission for each sale as well as future Affinity Line commissions when they begin building their sales organizations.

3.2 Affinity Line Organization (Qualifying Sales from your Team)

When your Team Organization Marketing Associates sponsor their first 2 Marketing Associates (their qualifying sales to you) they become your Affinity Line Organization. They are not displayed in your “Affiliate Members” area because you did not sponsor them. They are, however, displayed in your “Affinity Line” report in your back office as training sales from their sponsor. When these new Affinity Line Marketing Associates make their first 2 qualifying P1D sales they are also passed up to you and become additions to your “Affinity Line” report. With your guidance and support and the training and mentoring from SMG your Affinity Line organization can become infinitely wide and infinitely deep and create an income without limits.

3.3 Personal Retail Customers

When an Independent Representative makes a netTrav.com Membership sale or a P1D Membership sale to a retail customer who does NOT purchase the Online Business System, the customer will be listed in the Representative’s back office under “Retail Members”. They will not be listed in your “Affiliates Members” or “Affinity Line” reports.

SECTION 4 REPRESENTATIVE QUALIFICATIONS AND PROMOTIONS

4.1 How to Become Commission Qualified with a Membership purchase.

4.1.1 netTrav.com Affiliate:

A netTrav.com Affiliate purchases the \$49 Online Business System and a netTrav.com Membership that includes their personal netTrav.com Website. A netTrav.com Affiliate is immediately qualified to earn Direct Commission on every netTrav.com Membership that they sell in addition to receiving commission (Rebates) on all (commissionable) travel that is booked from through their netTrav.com website.

4.1.2 P1D Marketing Associate Accelerated Wealth Program:

Getting started in the P1D Accelerated Wealth Program and becoming a P1D Marketing Associate is as simple as purchasing the \$49 Online Business System and a Silver, Gold or Platinum Membership.

4.1.2.A **Executive Marketing Associate** - 2 Personal Qualifying Sales:

A Marketing Associate becomes qualified to earn all commissions and to be promoted to EMA at the P1D Membership Level that they purchased after completing 2 sales at any P1D Membership Level.*

Example #1: A **Silver Marketing Associate** who makes ANY 2 P1D Membership Level sales is promoted to a Silver EMA and will earn \$750 on any Silver, Gold or Platinum Membership direct sale from their 3rd sale and all subsequent sales and will earn \$750 on all Affinity Line Qualifying sales from their team.

If the Silver EMA makes a Platinum Membership sale they would earn \$750 and the \$6,750 Gold and Platinum Override Commission would pass up to the qualified Gold and/or Platinum Upline EMAs.

Example #2: A **Gold Marketing Associate** who makes ANY 2 P1D Membership Level sales (even 2 Silver sales would qualify) is promoted to a Gold EMA and will earn \$750 on a Silver Membership sale and \$3,000 on Gold or Platinum Membership direct sales from their 3rd sale and all subsequent sales and will earn \$750 to a maximum of \$3,000 on all Affinity Line Qualifying sales from their team. If the Gold EMA makes a Platinum Membership sale they earn \$3,000 and the \$4,500 Override Commission passes up to the qualified Upline EMA/EMA's.

This Gold EMA earns up to \$2,250 more per sale than the Silver EMA in Example #1.

Example #3: A **Platinum Marketing Associate** who makes ANY 2 P1D Membership Level sales (even 2 Silver sales would qualify) is promoted to a Gold EMA and will earn \$750 on a Silver Membership sale and \$3,000 on Gold and \$7,500 on a Platinum Membership direct sales from their 3rd sale and all subsequent sales and will earn \$750 to a maximum of \$7,500 on all Affinity Line Qualifying sales from their team. No Direct Commission is passed up to the qualified Upline EMA/EMA's; all \$7,500 of Direct Commission is retained by the Platinum EMA.

This Platinum EMA earns up to \$4,500 more per sale than the Gold EMA in Example #2 and up to \$6,750 more per sale than the Silver EMA in Example #1.

4.1.2.B **Executive Leader**

Gold and Platinum EMAs may qualify to become an Executive Leader and to receive EL Bonuses on Gold and/or Platinum sales in their downline organization. The requirement to become Executive Leader is twofold:

(1) After qualifying as an EMA you must make 4 more P1D Membership sales that are at the Membership Level that you own or higher.

(2) You must also have 2 Marketing Associates* from your Direct Team Line be promoted to EMA at your Membership Level or higher. (* no more than 1 of these 2 EMAs may be a member of one of your Affinity Lines)

Example #1: Bill is promoted to a Gold EMA and then sponsors 4 new Gold Marketing Associates. Bill then helps 2 of those 4 Marketing Associates get promoted to Gold EMA. Bill is now a Gold Executive Leader.

Example#2: Bill is a Platinum EMA and then sponsors 2 new Gold Marketing Associates and 2 new Platinum Marketing Associates. Bill then helps 2 of the Platinum Marketing Associates get promoted to Platinum EMA. Bill is now a Gold Executive Leader and a Platinum EMA. In this example, Bill now only needs to sponsor 1 more Platinum Marketing Associate to become a Platinum Executive Leader.

4.1.2.C Upgrades: Membership Upgrade Qualifications and Promotions

Affiliates, netTrav.com Affiliates and P1D members may upgrade to a higher Membership at any time. In addition to enjoying the related Travel Products and Reward Points of their upgraded Membership Level, the Representative has significantly increased their income potential. To qualify as an EMA at this new upgraded Commission Level the Representative will be required to make 2 additional sales at the same or higher Membership Level AFTER their Membership upgrade purchase.

Note: How to Become Commission Qualified without a Membership purchase.

An Affiliate may purchase a \$49 Online Business System and become qualified to earn commissions by making 5 Membership sales. A netTrav.com Affiliate may purchase the \$49 Online Business System and a netTrav.com site for \$99 (\$148 Total) and become qualified to earn EMA commissions on all future P1D sales after making 5 P1D Membership sales. Commissions for these sales are paid to the Affiliate's Upline Organization as described in detail in Section 4.

1. netTrav.com Qualified: An Affiliate may sell 5 netTrav.com Memberships to become qualified to receive direct commissions on all netTrav.com Membership sales after their 5th sale. The Affiliate will receive a netTrav.com Membership upon completion of their 5th sale and is promoted to netTrav.com Affiliate.
2. P1D EMA Qualified: An Affiliate or netTrav.com Affiliate may sell 5 P1D Memberships to become qualified to receive direct commission on all P1D Membership sales after their 5th sale. The 5th sale the Affiliate is promoted to EMA at the lowest level of P1D Memberships sold with the 5th sale and will receive their own P1D Membership at that same Level.

Example #1: An Affiliate or netTrav.com Affiliate sells 5 Platinum Memberships. The Member is now a Platinum EMA and has received a Platinum P1D Membership.

Example #2: An Affiliate or netTrav.com Affiliate sells 3 Silver and 2 Gold P1D Memberships. The Member is now a Silver EMA and has received a Silver P1D Membership. To become a Gold EMA (without purchasing the Gold Membership and then making 2 Gold Membership sales) this Member may sell any combination of 5 Gold or Platinum Membership sales. To become a Platinum EMA without purchasing a Platinum Membership and making 2 Platinum Membership sales, this Member may sell 5 Platinum Memberships.

4.1.3 Minimum Retail Sales Requirement

P1D Marketing Associates, Executive Marketing Associates and Executive Leaders must produce a minimum of \$297, in retail product sales every quarter in order to remain eligible to earn Direct Commissions, Affinity Line Commissions and Residual Team Earning Center (RTEC) Commissions. The Minimum Retail Sales Requirement retail sales include the \$99 netTrav.com membership and Silver, Gold or Platinum Memberships to someone who does not purchase the \$49 Online Business System. Selling retail Silver, Gold or Platinum P1D Membership will qualify the EMA for two quarters.

If the minimum retail sales requirement is not met, the member will have an in-active status. All Direct Commissions, Affinity Line Commissions and Residual Team Earning Center (RTEC) Commissions will be forfeited by the member and retained by P1D during the member's in-active status. The Member will have a status as an in-active member until they produce the minimum retail sales requirement to become an active member again. If the retail sales requirement is met, the member will be paid on their personal retail sales that resulted in them regaining their active status and all other commissions that are earned by them from that date forward as an active member.

NetTrav.com Affiliates do not have a Minimum Retail Sales Requirement. Rebates from the member's netTrav.com site are not subject to forfeiture during their in-active status.

SECTION 5 AFFILIATE AND REPRESENTATIVE COMMISSIONS

5.1 Overview

Platinum One Destinations pays our Representatives commission on all netTrav.com Membership sales and on all P1D Silver, Gold and Platinum Membership sales as well as commission rebates on travel that is booked from the Representative's netTrav.com Website. Travel Commission Rebates can be exchanged for travel or cash.

Below is the commission paid for each of the Memberships listed above. It is important to note that each Membership includes the lower Memberships. For example, a Platinum Membership includes a netTrav.com Website and the Silver and Gold Membership benefits.

* Note: Team and Affinity Line Commissions, Executive Leader Bonuses and RTEC Commissions and Bonuses are only available in the P1D Accelerated Wealth Program.

5.2 netTrav.com Commissions – 2 Income Streams

netTrav.com Affiliate Representatives earn \$50 each time they sell a netTrav.com membership to a Retail Customer or to a new Member who becomes a netTrav.com Affiliate. netTrav.com Affiliates also earn a 50% Travel Rebate on all travel that is booked from their netTrav.com Website after the travel has been taken and Net Trav Inc. has been paid.

5.3 P1D Accelerated Wealth Program – 8 Income Streams

Platinum One Destinations Representatives can earn a powerful income from 8 Income Streams with 4 of these Up Front Direct Income Streams and 4 Residual Income Streams. These 8 Income Streams are described below.

4 UP FRONT DIRECT INCOME STREAMS

5.3.1 NetTrav.com Membership Sales - Direct Commission

Earn \$50 on each netTrav.com Membership you sell.

5.3.2 P1D Membership Sales – Direct Commission

As an EMA at the P1D Membership Level that you own, you will earn direct commissions on each sale that you make. You earn \$750 to \$7,500 for each sale that you make based upon the Level of the Membership sold and your EMA Qualification Level. See Chart 4.3.2 below.

You earn Direct Commission up to the EMA Level of the P1D Membership that you own.

5.3.3 Affinity Lines – Qualifying Sales Commissions

As an EMA at the P1D Membership Level that you own, you will earn Qualifying Sales Commissions from the first 2 sales made by the Marketing Associates in your Affinity Lines. You earn \$750 to \$7,500 for each Affinity Line qualifying sale made based on the Level of the Membership sold and your EMA Qualification Level. See Chart 5.3.3 below.

You earn Affinity Line Commission up to the EMA Level of the P1D Membership that you own.

5.3.4 Travel Sales Commission

Earn a percentage of the Travel Commissions paid to Net Trav Inc. Inc., booked on your netTrav.com website. The percentage of Travel Commission you earn is based upon the P1D Membership Level that you own. See chart 5.3.4 below.

*Note: This is a percentage of the commission paid to Net Trav Inc. on the travel booked, not a percentage of the total cost of the travel booked.

4 POWERFUL RESIDUAL INCOME STREAMS

5.3.5 Upgrade Sales and Overrides

A. Upgrade Sales: As netTrav.com Affiliates and Silver and Gold Members of your Team and Affinity Line Organizations grow their P1D businesses, they will want to purchase an upgrade to their Membership and work to become EMA qualified at the higher Membership Levels so that they can increase their earning potential. Your EMA Level will determine the

commission that you are paid on these upgrades. To purchase an upgraded Membership the netTrav.com, P1D Silver or Gold Member would log into their P1D back office and select “Membership Options” and complete their upgrade by paying the difference in the purchase price between the Membership they own and the Membership to which they upgrade.

Note: netTrav.com Affiliate may upgrade within 30 days of their original purchase and receive a \$99 credit towards the upgrade. In this case the commission to the EMA is reduced by \$50 because a \$50 commission is paid on the original netTrav.com purchase.

B. Overrides: Overrides and additional Affinity Lines are created whenever a Team Line or Affinity Line Member produces a sale above their qualified EMA P1D Membership Level.

C. Override Commission: The selling EMA receives commission up to their EMA qualification level and the rest of the commission is called an “Override” and is paid up to the first qualified Gold and/or Platinum EMA or EL. See Chart 5.3.5.B & C.

D. Affinity Lines from “Override” sales follow the Representative who receives the Direct Commissions and becomes new Affinity Lines for that Representative. The selling EMA will retain the future Commission from the qualifying sales and the Affinity Lines created ONLY at their qualified EMA Membership Level. The (1) future Commissions from the qualifying portion of the sale above the seller’s EMA Level and the (2) Affinity Lines created are passed up to the same EMA/EL that received the commission on the Override sale.

Example: Andy purchases a Platinum Membership from his sponsor Bob who is a Gold EMA. Bob receives a Direct Commission of \$3,000 and the Silver and Gold Affinity Lines created by Andy. Cindy is the first Upline Platinum EMA from Bob, and receives the \$4,500 Platinum portion of the Direct Commission of \$4,500 and Andy's future Platinum Affinity Lines.

Now if Andy then made a Platinum sale as his first qualifying sale, the Direct Commission would be paid out the same way with Bob receiving \$3,000 and Cindy receiving \$4,500.

5.3.6 Leadership Bonuses (Executive Leader)

Executive Leadership Bonuses are paid on all new Gold and Platinum Membership purchases and on all Gold and Platinum Membership upgrades. Every Gold Sale pays out a Gold EL Bonus. Every Platinum Sale pays out Gold & Platinum EL Bonuses. The same EL may qualify to receive BOTH bonuses on a Platinum Sale made in his or her organization. See Chart 5.3.6.

*Note: In this case the entire Executive Leader bonus was paid to the Platinum Executive Leader because there was no Gold Executive Leader in the Upline between the Platinum EMA and the Platinum Executive Leader.

If an Executive Leader earns a Direct Commission on a Gold Membership sale, then the Gold EL Bonus is passed Upline to the next Upline Executive Leader.

If an Executive Leader earns a Direct Commission on a Platinum Membership sale, then the Platinum EL Bonus is passed Upline to the next Upline Platinum Executive Leader.

It is possible for a Platinum Executive Leader to receive both a Direct Commission and an EL Bonus on the same membership sale.

Example: Linda, a Gold EMA makes a Platinum Membership sale to Ron. Linda, the Gold EMA receives the Gold Direct Commission of \$3,000. Carol, Linda's sponsor is a Platinum EL and receives the \$750 Gold EL Bonus. Carol also receives the \$4,500 Platinum Direct Commission and future Affinity line commissions. The Platinum EL Bonus then passes Upline to the next Platinum Executive Leader directly above Carol.

5.3.7 Direct Commission - Residual Team Earning Center (RTEC)

When a Silver or higher MA purchases their Membership, an RTEC is created for them. An RTEC is a software automated revolving “follow your sponsor” system of residual income. It consists of 6 positions and fills with a total of 6 sales. You are paid on 4 of the 6 positions for a total of up to \$500 for each completed RTEC. When your RTEC is completed, you are automatically entered into your next RTEC “following your sponsor” without cost to you. If you have not yet made your first P1D Membership sale you will earn \$62.50 on each of the 4 positions as they fill. As soon as you make your first P1D Membership sale you will begin earning \$125 for each of the 4 positions from that point on.

The RTEC system was created to give anyone an opportunity to “earn while you learn” by providing veteran marketers with a bonus income that works without any attention or effort. Your RTEC works inter-dependently with your Team and Affinity Lines as well as the Team and Affinity Lines of your Sponsor.

5.3.8 50% Matching Bonus - Residual Team Earning Center (RTEC)

P1D Executive Marketing Associates earn a 50% Matching Bonus on the RTEC Direct Commission earned by all of their personally sponsored Representatives. If a Representative that you sponsor earns \$250 in their RTEC you receive a 50% match of \$125. If they earn \$500 in their RTEC you receive a 50% match of \$250.

5.4 Commission Payment Schedule

5.4.1 Affiliate and Representative Commissions

Commissions are paid weekly on all Commissions listed in Section 4 of this document. Weekly commissions are calculated on Friday of each week for sales that were approved and finalized by midnight of the previous day. Approved and finalized sales include the following, 1) sales where the Credit Card purchase has been approved by the purchaser’s credit card company, 2) payment made by Virtual Check has been paid to P1D, 3) direct deposits or wires that have been received in the P1D bank account, and 4) are outside of the 7 day refund period. P1D reserves the right to release Commissions on Approved sales that are not finalized. See 5.4.2 below.

5.4.2 Refunds and Charge Backs

Platinum One Destinations reserves the right to recover sales commissions paid to a representative any time a commissionable purchase of a netTrav.com website or a P1D Membership is refunded, for any reason, to the purchaser.

Platinum One Destinations will refund any unsatisfied purchaser of any Platinum One Destinations or netTrav.com Membership product one-hundred-percent (100%) for a period of 7 days from the date the product was electronically received. After the expiration of the 7-day period there will be no refund. Weekends and Holidays will not count in the calculation of the 7-day period.

SECTION 6 TRAVEL REBATES AND COMMISSIONS

6.1 Overview

All members who have a netTrav.com Membership are eligible to earn rebates on travel that is booked on their site. Rebates may be earned on travel that you book as well as travel that is booked by anyone that you send to your site.

Most consolidator and standard hotel, car and vacation package travel transactions that you or anyone books through your netTrav.com site will provide rebates back to you. The amount of the Rebate earned by you will be determined by the source of the travel booked and then your percentage of that total commission is determined by your netTrav.com, Silver, Gold or Platinum Membership Level. Some travel, such as domestic airfare and a few select other transactions; will not have a commission associated with it. Whenever a commission is not available, it is because of the specific vendor's industry wide policy, and not specific to netTrav.com or Platinum One Destinations.

6.2 Travel Rebate Percentage

The Rebates you receive are based on your Membership Level. The higher Membership Level you own, the higher your Rebate percentage. Your Rebate is a percentage of the Travel Commissions paid to Net Trav Inc./P1D from the Travel booked on your netTrav.com.

6.3 netTrav.com Consumer and netTrav.com Affiliate Travel Rebates

All Travel Bookings and Rebates are reported in your netTrav.com back office every Wednesday by 12:00 Midnight PST. Commissions are paid to Net Trav Inc. either when the travel booking payment is completed or after the travel has been completed, depending on the vendor. When Net Trav Inc. has received the commission, the Rebate Status will change to Available. Rebates which have an Available Status can then be requested and will be paid by Company check.

6.4 P1D Membership Travel Rebates and Reward Points

P1D Members have the same rebate reporting system in their netTrav.com back office as well as in their P1D back office.

P1D Members also enjoy access to P1D Travel Products and are able to exchange reward points for the lowest possible price on the components of their travel where Reward Points can be used to lower the price. There may be a trip or components of a trip that is not from P1D inventory and not associated with P1D Reward Points. In these cases, if P1D/Net Trav Inc. receives a commission from the supplier, the Member will receive the rebate appropriate for their level of Membership as described in the 6.2 Chart above. The rebate will be reported and processed as described in 6.3 and 6.5.

6.5 Travel Rebate Conversion to Payment

netTrav.com Consumer Owners, netTrav.com Affiliates and P1D Members may request a rebate check when Available Rebates total \$100.00 or more. This request is made in your netTrav.com or P1D back office. Travel rebate checks are issued monthly on the 15th and 30th.
